Any changes to the tenants at the property should be discussed with the property manager/owner before submitting a Change of bond contributors request.

Successfully submitting a Change of bond contributors request does not change the tenants listed on the tenancy agreement. It only changes who is listed on the bond and/or their bond contribution amounts held by the RTA. Any changes to the tenancy agreement (also known as the lease), require approval from the property manager/owner.

## Bond loans

If you currently have a bond loan, you need to contact the Department of Housing, Local Government, Planning and Public Works, (DHLGPPW) to request approval for the removal of a tenant from your bond.

Once DHLGPPW confirms their approval this form can be completed and sent to the RTA. No new tenant/s can be added to a bond with an outstanding loan balance.
